#### ENTITLEMENT TO PARTICIPATE AND VOTE REMOTELY

All members of the Company, whether individual members, corporate members, proxy holders, authorised nominees or exempt authorised nominees whose names appear on the Record of Depositors of the Company as at **03 June 2022** that wish to attend the 20<sup>th</sup> AGM will have to register to attend remotely by using the RPV facilities, the details of which is set out below.

For members who are unable to participate in the 20<sup>th</sup> AGM, you may appoint proxy or the Chairman of the Meeting as your proxy to attend and vote on your behalf at the 20<sup>th</sup> AGM. The duly completed Proxy Form must be deposited at the registered office of the Company, 51-21-A Menara BHL Bank, Jalan Sultan Ahmad Shah, 10050 Georgetown, Penang not less than 48 hours before the time for holding the meeting or adjournment thereof.
